SCGPM is wholly owned and controlled by Satori Capital, which is indirectly owned and controlled by Sunny Vanderbeck and Randy Eisenman through entities that Sunny Vanderbeck or Randy Eisenman own or control. SCGPM is the manager of Satori CSOGP and SCIII GP and may be deemed to share voting and dispositive power with respect to the shares held by Satori CSO and SCIII. Satori CSOGP, is the general partner of Satori CSO, which directly holds 571,538 shares of Common Stock and 341,285 shares of Common Stock issuable upon the exercise of warrants. SCIII GP is the general partner of SCIII, which directly holds 249,047 shares of Common Stock and 148,715 shares of Common Stock issuable upon the exercise of warrants.

Each of Satori CSOGP, SCIII GP, SCGPM, Satori Capital, Mr. Vanderbeck, Mr. Eisenman and each entity through which Mr. Vanderbeck and Mr. Eisenman indirectly owns or controls Satori Capital disclaims beneficial ownership of the securities held by Satori CSO and SCIII.
